Sub:- Conferment of Autonomous Status to Deccan Education Society's Brihan Maharashtra College of Commerce, 845, Shivajinagar, Pune-411 004 affiliated to Savitribai Phule Pune University Ganeshkhind, Pune-411 007

Sir/Madam,

This is with reference to the proposal submitted by Deccan Education Society's Brihan Maharashtra College of Commerce, 845, Shivajinagar, Pune-411 004 affiliated to Savitribai Phule Pune University Ganeshkhind, Pune-411 007 under the UGC Scheme for Autonomous Colleges.

On the basis of the report of the UGC Expert Committee and on the basis of the recommendations of the Standing Committee, the Commission has decided to grant autonomous status to Deccan Education Society's Brihan Maharashtra College of Commerce, 845, Shivajinagar, Pune-411 004 affiliated to Savitribai Phule Pune University Ganeshkhind, Pune-411 007 for a period of ten years w.e.f. 2017-2018 to 2026-2027.

Savitribai Phule Pune University Ganeshkhind, Pune-411 007 may issue necessary notification/order regarding the grant of autonomous status to the college as per the UGC Guidelines for Autonomous Colleges. The college, if eligible, shall apply for autonomy grant as per the norms laid down in the Guidelines.

The autonomous college shall be guided by the provisions of the UGC Guidelines for Autonomous Colleges. The Guidelines are available on the UGC website, <u>www.ugc.ac.in</u>. However, the college may take special note of the following:

- (a) The college will constitute the Internal Quality Assurance Cell (IQAC) under intimation to UGC. The Cell will have an external Peer Team comprising of academicians of repute and will send report to UGC regarding the performance of the college. The report will also be put on public domain on the website of the College. The external peer review shall be conducted atleast once in a year.
- (b) If the college is currently accredited by NBA only, it must undergo NAAC accreditation within two years of conferment of the autonomous status.

(c) The college will apply to University Grants Commission for extension of autonomous status six months prior to expiry of the autonomy cycle. If the college does not apply within the stipulated time, University Grants Commission will be at liberty to withdraw the autonomous status of such college.

A copy of the UGC Expert Committee report is enclosed herewith for information of the college.


