1. Laboratory computers-

Students will in no way damage or tamper the laboratory computers.

Laboratory computers shall be used only for laboratory practical assignments.

2. Wi-fi and LAN connectivity to devices-

Wi-fi and LAN connectivity will be available as is. Valid username and password obtained from Computer Services Office is required when accessing wi-fi and LAN network. Internet services provided will be guarded by firewall. Firewall policies will have to be adhered to. Wi-fi or LAN connectivity is not supposed to be used to access any unauthorized content or hack any internal or external systems or sites.

3. ERP system access-

ERP system can be accessed from mobile and PC. Students will not share login Id or password with anyone. 




