After verification of documents the admission form will be active in ERP Login Id.

Enter received user ID & Password on register mobile no. Fill form, give preference to elective of your choice. Students should select subject

group, & then click on Add button. You have to give minimum 3 preferences. After preference click on save & next, check preview & then confirm form. After confirmation click on Pay Now button, & pay the fees online After preference, merit list will be prepared, and student will get the subject of her/his preference on merit basis.

Fees are to be paid in two installments as per category. First installment at the time of admission and Second installment between 25th to 30th November, 2021 without fail.

Admissions from this list must be secured on 28.10.2021 (between 10:30 a.m. to 1:30 p.m.) As per schedule mentioned below. **Students should note that if they do not confirm their admissions in the given period on 28.10.2021 they shall loose their claim and shall not be given admissions thereafter.**
