**Item No.1**

Preamble:- BMCC College had applied for Autonomy on recommendation of DES Governing Body as per their Resolution No.GBR-34/20.04.2016 through Savitribai Phule Pune University in December 2016. The committee of the University Grants Commission visited the college on 17<sup>th</sup> and 18<sup>th</sup> June 2017 and Autonomy was granted to the college by the UGC and Savitribai Phule Pune University.

The Alumni and Industrial experts were invited for a meet in which, a basic draft of syllabi was discussed by faculties. The changes were suggested by them were incorporated. The draft of the syllabus was proposed by the faculty in the meetings of respective Board of Studies (BoS), where in two experts from other university were invited as members.

The college submitted a letter to the SPPU, requesting appointment of representatives in our BoS on 11<sup>th</sup> July 2017. The representatives were still awaited thus, in the interest of the students and for the academic purpose, the meetings of BoS were held without the subject experts from SPPU. Suggestions made by external members are incorporated and accordingly the draft was presented for approval in the Academic Council.

Principal, Dr.C.N.Rawal after welcoming all the members of the Academic Council, Dr.A.M.Puranik, Secretary of Academic Council, briefed the process of autonomy as practiced by the autonomous colleges. The members present in the meeting introduced each other as requested by the Chair.
