Academic Governance related matters for UG and PG covered the following:

1. Dr.A.M.Puranik, Vice Principal, briefed about the skilled courses in BMCC and the need to increase the credits from 120 to 132 credits as per the UGC guidelines.
2. He also justified the remuneration to paper setter as well as for the project guides.
3. Remuneration for the project in selected papers, for which the credits were in increased from 3 to 4 are as follows;

Further the Principal BMCC is authorized to form a committee to identify and explore Swayam and MOOCs courses for additional credits to benefit the students in terms of availability of various options. Item No.6

Recommendations from Exam Committee :- A detailed report regarding exams was read by Prof. Priti R.Rajguru, COE, BMCC. Following points were discussed.

- i. The examinations of first semester of all courses including the backlog papers were successfully conducted online in MCQ format, with the support from the ERP team, due to the pandemic situation prevailing.
- ii. Final Exam for UG courses is scheduled in the second or third week of May, 2021.
- iii. Suggestions by CA Shri Sagar Phadke, Chairman, CDC, BMCC :- To ensure that the students are evaluated with descriptive type questions and even open book exam to be undertaken in the online or offline mode.

Item No.8

Approval of Board of Studies (BoS) Recommendations

- The respective Board of Studies approved the increase in credits from 3 to 4 in selected papers of specialization and for Financial Accounting in the First Year of B. Com and in Second Year for Business Economics (Macro)
- The increase in the number of teaching hours from 45 hours to 60 hours for BBA, BBA (IB) and BBA (CA) courses to increased the credits form 3 to 4, has been accepted.
- The revision was undertaken for one additional credit for projects under various courses. To incorporate projects, minor changes in the syllabus is considered and the approval from the respective BoS is obtained.

Following Suggestions were made by CA Shri Sagar Phadke, Chairman, CDC, BMCC

- i) Arrange one day orientation for students before starting project work.
- ii) Add few projects related to Administration bodies at local level such as Gram Panchayats, Zilla Parishads, Municipal Corporations, NGOs and study the Administrative, Management, HR, related issues.
- iii) Relationship management with the citizens should be explored with NGO and public sector units, in live projects. Students should be encouraged to undertake projects on Development of E-Governance, Pension related projects, etc.
- iv) Arrange individual viva or evaluation for the projects undertaken by the students.
- v) Propose linkages between program outcome and learning outcome (PO and CO) and examination for the Academic year 2021-22.

- viii) Send corrected / updated list of all 28 courses to all members for getting their feedback.
- ix) Add topics like, Computational sustainability and financial sustainability in the syllabus.
- x) Topics of Extensible Business reporting language to be included in the syllabus of Business Communication during Semester I and II.

BMCC/ACR-05/08.02.2021:- Resolved that, the revised 2017 Syllabus with additional credits in specialized papers and few selected papers of all undergraduate courses for First Year and Second Year as recommended by the various Boards of Studies be and are hereby approved and forwarded to GB (BMCC) for further approval. The number of hours from 45 to 60 hours for BBA, BBA (IB) and BBA (CA) to increase the credits from 3 to 4 as recommended by respective BoS be approved and forwarded to the GB (BMCC).
