 - b) 10th and 12th Mark sheet
 - c) Scanned copy of Passport size photograph & Sign (Less than 500 KB).
 - d) UID (Aadhar Card)
 - e) Upload Documents If applicable (Caste /Category/ Defense /Army/ Sports/ specially Abled)

- 1) Click on Go to Sign Up, fill all valid information- student will get message on registered mobile no. and email, given while filling the application form.
- 2) Use this username and password and login.
- 3) Read instructions carefully and click on continue.
- 4) Fill all the fields, information in application form. Incorrect information will result in cancellation of name from the list.
- 5) For Admission type tab students passed the TY examination should select following Options:
 - UG from SPPU Maharashtra Students - Home University SPPU Maharashtra,
 - UG from SPPU Non Maharashtra Students - Home University SPPU Non Maharashtra,
 - UG from Other Universities in Maharashtra - Other University Maharashtra
 - UG from Other Universities in Non Maharashtra - Other University Non Maharashtra
- 6) Those students who have applied from Non Maharashtra will be treated as Open category student only.
- 7) On “Last Qualifying Exam” detail page, fill UG exam details and on “Education details” page, fill 10th &12th Exam details.
- 8) Sports students are requested to submit online applications along with all necessary documents.

Important - Fill the application form online. No need to submit hardcopy in office.

The admission is provisional subject to the verification of original documents & final approval of eligibility. In case, of false information filled, the admission of the candidate will be cancelled immediately and the candidate as well as his parent/guardian will be responsible for the consequences and the candidate will be removed from the merit list.
